Overall, the April 20, 2016 Post-Election Audit went well.

The two wards randomly selected for audit include:

- City of Madison, Ward 39
- City of Stoughton, Wards 5-6

Auditors David Spies (Lead Auditor) and Anne Habel served as ballot couriers on Monday, April 18, 2016 to collect ballots from City of Stoughton Clerk Lana C. Kropf, and to transport ballots, maintaining chain of custody at all times, to Dane County Clerk Scott McDonell. Ballots for City of Madison, Ward 39, were transferred to Dane County Clerk Scott McDonell via the City of Madison Clerk's Office (Maribeth Witzel-Behl, Madison City Clerk).

Auditors David Spies (Lead Auditor), Anne Habel, Brian Murray, David Diamondstone, and Anne Murphy-Lom went to Room 354, City-County Building, Madison, WI on April 20, 2016 to conduct an audit of paper ballots for City of Madison, Ward 39 and City of Stoughton, Wards 5-6 from the April 5, 2016 election.

**Audit Timeline (verifying Chain of Custody) April 20, 2016:**

**8:30 am:** Lead Auditor arrived at City-County Building to verify room set-up/accessibility

**9:30 am:** All auditors met in lobby of City-County Building to discuss procedure and receive audit paperwork:

**9:50 am:** Auditors obtained chain-of-custody initials; receive Ballot Bags, Polling Place Incident Reports with location-specific County Election night Report Tapes, and Precinct Reports; all auditors maintained chain-of-custody during final transport of materials to Room 354, City-County Building; upon entry to room, auditors publicly announced *"We are auditors with the Dane County Clerk's Office. Our purpose is to conduct a public meeting regarding a post-election audit of paper ballots of select Dane County polling locations from the April 5, 2016 Election. The randomly selected wards are City of Madison Ward 39 and City of Stoughton Wards 5-6."*; Auditors unloaded audit materials and prepared audit room.

**10:00 am:** Lead Auditor made introductory remarks to 6 observers in the room; allowed 5 minutes for public comment

**10:15 am:** Lead Auditor assigned Auditors Brian Murray and David Diamondstone to audit City of Stoughton Wards 5-6, assigned Auditors Anne Habel and Anne Murphy-Lom to audit City of Madison Ward 39.

**10:20 am:** Audit commenced.

- Stoughton Auditors: Ballot Bag #0018552 with 526 ballots was opened and tallied first.
- Madison Auditors: Ballot Bag #00075276 with 584 ballots was opened and tallied first

**10:40 am:** Hannah Flood, Reporter for NBC Channel 15, Madison, arrived with credentials and television camera in hand to take footage and interview Lead Auditor and Dane County Clerk. Lead Auditor permitted request to

take distant footage (preserving privacy of ballots) but requested that all interviews take place outside the audit room to minimize disruption. Flood remained for approximately 90 minutes.

**2:30 pm:** Madison Auditors: Ballot Bag Seal #0075275 with 602 ballots was opened and tallied second.

**4:04 pm:** Stoughton Auditors: Ballot Bag Seal #0018551 with 792 ballots was opened and tallied second. Lead Auditor assisted throughout this bag, and Madison Auditor Anne Murphy-Lom assisted after 7:30 pm.

**6:00 pm:** Madison Auditors completed final bag tally; reviewed and reconciled tally sheets.

**8:30 pm:** Stoughton Auditors completed final bag tally; reviewed and reconciled tally sheets. Lead auditor reviewed all Audit Tally Sheets and Audit Inspectors Statements. All auditors reviewed Audit Inspectors Statements. Dane County Clerk Scott McDonell arrived at Rm 354 to prepare for transfer of materials to Dane County Clerk's Office (maintaining chain of custody).

**8:45 pm:** Madison Auditors resealed ballots in new ballot bags.

**9:10 pm:** Dane County Clerk received all paperwork and ballots. Ballots were secured in Dane County Clerk's Office.

**9:30 pm:** Audit complete. All auditors left City-County Building simultaneously, escorted by Dane County Clerk.

## **Observations (April 20, 2016 Post-Election Audit)**

As was predicted in the March 10, 2016 audit report, paper ballots took significantly longer to count than electronic ballot images. There were 5 auditors auditing the Madison and Stoughton polling locations simultaneously. As the Stoughton polling location included 2 wards, it was logical that auditors completed the Madison ward earlier than the Stoughton wards (Madison auditors contributed to the Stoughton audit upon completion of their duties). The audit timespan of 11 hours for the cumulative audit (2504 total ballots audited between Madison and Stoughton) was longer than predicted due to several instances of tally discrepancies by the Stoughton auditors which needed to be reconciled.

There were minor differences in totals detected by auditors in both Madison and Stoughton. However, they appeared to be within a standard margin of error.

There were several instances where voters had clearly communicated voter intent yet creatively marked ballots in a manner which could not be detected by the machine. Instances included:

- Ovals with an "X" over them
- Lines inside the ovals which didn't adequately fill in the oval
- Circled names
- Circled ovals

Clarification is needed as to whether write-ins should be counted at the audit if there are no certified write-in candidates.

Madison Auditors presented some "best practices" regarding tally procedure. Lead Auditor will follow up and include this in revision of tally procedure prior to August audit.

**Action Plan:**

- Lead Auditor should continue to refine audit procedures prior to the August Audit, reflecting recommendations and best practices.
- Lead Auditor should revise forms prior to August to include an Audit Courier Chain-of-Custody section.
- Lead Auditor needs to schedule a date and room for the August 2016 Post Election Audit, secure audit staff and materials, and arrange for parking for auditors on the days of the audit.

- ☐ (Upon entry to audit room) Publicly announce "***We are auditors with the Dane County Clerk's Office. Our purpose is to conduct a public meeting regarding a post-election audit of paper ballots of select Dane County polling locations from the XXXXXX Election (list select polling locations).***"
- ☐ Brief observers on audit procedure (Allow 5 minutes total for public comment per Public Meeting rules)

## Set Up Audit Stations:

- ☐ Assign auditors in pairs (3's) per polling location (set up within view of observers)
- ☐ Designate a **publicly visible location nearby**, inaccessible to observer access, for unsealed but tallied ballots.
- ☐ Distribute polling location ballot bags to auditors for count and tally

## Confirm Bag Ballot Count:

The following procedures should be conducted for **each and every bag** presented for audit (conducted by auditors in pairs/3s):

- ☐ **Confirm seal numbers as well as that the seal is intact.** (Only once the seal information is confirmed and initial information on the tally sheets is filled in can the ballot bag be opened and ballots removed for tally.)
- ☐ **Divide ballots in half;** assign each half to an auditor
- ☐ **Count the ballots in stacks of 10,** alternating stacks (Landscape/Portrait), until they are complete. (**IMPORTANT: Each auditor should NOT announce how many ballots to the other auditor, but make a note for later comparison.**)
- ☐ Once counted, **pass the respective ballot stack to the other auditor**, who will conduct a similar count.
- ☐ **Once the stacks have been counted by each auditor, the counts should be announced to one another.** Only after confirmation of totals by each auditor has been reached should the audit proceed. (A third auditor can assist if needed.) It is **critical** that an accurate count of ballots be confirmed prior to tally, in order to confirm results upon completion.

## Ballot Tally/Reconciliation:

Once a ballot total for the bag has been confirmed, the following procedure is recommended (based upon previous audits conducted in 2016):

Each auditor maintains one Audit Tally Sheet for each selected polling location.

### **Auditor #1 Duties** (switched throughout count to maintain alertness):

- ☐ Publicly announce indicated selection of each ballot (in groups of 10); place tally mark as indicated on Audit Tally Sheet.

### **Auditor #2 Duties** (switched throughout count to maintain alertness):

- ☐ Visually confirm indicated selection of each announced ballot (in groups of 10); place tally mark as indicated on Audit Tally Sheet.

### **Auditor #3 Duties** (or Auditor #2 if not enough personnel):

- ☐ Keep a running tally (in groups of 10), confirming arrival at every 10. Also, ask each auditor to confirm their totals at every group of 10. If there is a discrepancy, **auditors must reconcile the discrepancy prior to proceeding to the next group of 10.** (This procedure has proved helpful in isolating tally error for reconciliation.)

### **Ballot Tally/Reconciliation (continued):**

Repeat process though every group of 10 until bag is successfully tallied. Once bag is tallied, each auditor shall confirm their bag tallies for later calculation.

- ☐ Place ballots with their unsealed ballot bag in designated **publicly visible location nearby**, inaccessible to any observer access, but **unsealed** should there be additional questions upon completion of the audit
- ☐ Confirm tally totals of bag. (Once all auditors have confirmed tally totals of the bag, they may proceed to the next ballot bag, following the same rules, until all ballot bags have been tallied.)

### **Confirm Polling Location Results:**

Once tallies have been completed and confirmed by all involved auditors, Lead Auditor shall present Publicly Announced Results. (**Troubleshooting tip:** in the event results do not match, auditors should determine if ballots were stuck together.)

Upon final confirmation of polling location results:

- ☐ Each auditor completes Audit Tally Sheet
- ☐ (Pair/3 Auditors): Reseal ballots according to their unsealed original ballot bags (along with the original, unsealed bags) in new ballot bags. **Each new bag should match the contents of the original bag plus the original bag, resulting in an appropriate number of bag seal numbers with identical ballot contents to the original bags.**
- ☐ **Log the new bag seal numbers** to confirm chain-of-custody:
  - Audit Tally Sheets
  - Audit Inspectors' Statement
  - Polling Location Inspectors' Statement

**Each new bag should match the contents of the original bag plus the original bag, resulting in appropriate bag numbers with identical ballot contents to the original bags.**

Upon completion of a polling location, 2 auditors should monitor the newly-sealed ballot bags for security, with remaining auditors offering to assist if necessary with any remaining polling location audit.

**Complete Paperwork/Return Audit Materials to County Clerk:**

- ☐ Upon completion of all polling location audit reconciliation, all auditors review Audit Tally Sheets and Audit Inspectors' Statement to confirm identical reporting
- ☐ Upon completion of audit, return all paperwork and ballots to Dane County Clerk to be secured and chain-of-custody completed
- ☐ 2+ auditors at all times transport ballot bags to Dane County Clerk maintaining chain-of-custody
